## 2020 Midyear Clinical Sessions for Recertification

Please note: Continuing Pharmacy Education Credit can be claimed by following general Midyear CE processing instructions.

The information below is intended for pharmacists seeking recertification credit, in one of these areas:

- Ambulatory Care Pharmacy, BCACP
- Geriatric Pharmacy, BCGP
- Oncology Pharmacy, BCOP

Several ASHP Midyear Clinical Meeting sessions were developed as a part of ASHP/ACCP's professional development program for recertification of board certified pharmacists. 4. Dual certified? Passing a recertification assessment for a session with multiple certifications will provide you hours for each of your specialties. For example, by passing the assessment for the "Managing Menopause: A "Hot" Topic" activity, you earn hours toward BCACP and BCGP. Sessions with multiple certifications are outlined in the Clinical Session table. You may purchase more than one specialty package.
