

2024 ASHP Midyear Intensive Studies for Recertification

Please note: Continuing Pharmacy Education Credit can be claimed by following general Midyear CE processing instructions.

The information below is intended for pharmacists seeking recertification credit, in one of these areas:

- Pharmacotherapy, BCPS
- Compounded Sterile Preparations Pharmacy, BCSCP

Several ASHP Midyear Clinical Meeting sessions were developed as a part of ASHP's professional development program for recertification of board-certified pharmacists. How does this work?
